# eGovPoliNet running activities

The **eGovPoliNet** project - which is running a series of activities aimed to establish an International Policy Community which deals with ICT solutions for Governance & Policy Modelling - has passed its 9 months of existence.

During this period, all partners have been involved in a wide range of international events such as to increase the awareness and the visibility of the project and to enlarge the Policy Community.



### **Dissemination & Liaison Activities**

Dissemination and liaison activities have actively continued. Partners have been promoting the project and its goals particularly both at international national and local level. All of them now provide information about eGovPoliNet on their websites and the eGovPoliNet website is being regularly updated with interesting news items.

Cooperation between eGovPoliNet and the CrossOver project! Network has been active.
